
WHEREAS, in a letter dated March 27, 2024, City Health Officer Dr. Arnold M. Pangan, MD, RSW, MPA, MMHoA requested for ratification of the Memorandum of Agreement (MOA) between the City Government of Manila and the Department of Health – Metro Manila Center for Health Development (DOH-MMCHD) for the provision of Health Emergency Allowance (HEA) for Health Care Workers (HCWs) and Non-Health Care Workers (non-HCWs) in the City of Manila;
