WHEREAS, on April 20, 2024 at 8:03 in the evening, a fire broke out and razed a portion of Barangay 679, Zone 74, District V, specifically at Pedro Gil Street, Paco, Manila, affecting fifteen (15) families rendering fifty-five (55) individuals homeless;

WHEREAS, the Sangguniang Barangay, through Punong Barangay Homar Sagad Sr., requested the City Council that their barangay be declared a calamity area so that their calamity fund be released to meet the needs of the victims: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to declare, as it hereby declares a portion of Barangay 679, Zone 74, Fifth District, a CALAMITY AREA; and be it FURTHER

RESOLVED, that a copy of this Resolution be furnished to the above-mentioned barangay for legislative support purposes to facilitate the immediate release of their barangay calamity fund.
