**RESOLUTION** LAUDING AND COMMENDING FILIPINO FOIL FENCER, MS. SAMANTHA KYLE CATANTAN, FOR WINNING THE WOMEN'S FOIL DIVISION AT THE ASIA-OCEANIA ZONAL OLYMPIC QUALIFIER ON APRIL 27, 2024 IN FUJAIRAH, UNITED ARAB EMIRATES

WHEREAS, the City Council of Manila has consistently given recognition and commendation to exemplary Filipino athletes for bringing honor and pride to the city and to the country by winning international competitions through relentless pursuit of sports excellence;

WHEREAS, fencing is an organized combat sport that originated as self-defense and offensive techniques for sword duels and military training in the 14th century;

WHEREAS, Ms. Catantan became the 12<sup>th</sup> Filipino athlete to officially qualify for the Paris Games which was made possible by winning the women's foil division at the Asia-Oceania Zonal Olympic Qualifier on April 27, 2024 in Fujairah, United Arab Emirates;

WHEREAS, she is the first Filipino Fencer in 32 years to compete in the olympics after Walter Torres who is now a Philippine Sports Commission (PSC) commissioner;

WHEREAS, through her strong will, determination and perseverance, Ms. Catantan brought honor to the Philippines which shall serve as an inspiration to aspiring athletes: NOW, THEREFORE, be it
