WHEREAS, under Section 34 (Role of People's and Non-Governmental Organizations) of R.A. 7160 (Local Government Code of 1991), local government units are mandated to promote the establishment and operation of People's and Non-Governmental Organizations to become active partners in the pursuit of local autonomy;

WHEREAS, Article 64 (Procedures and Guidelines for Selection of Representatives of People's Organization, Non-Governmental Organization or Private Sector in Local Special Bodies) of the Rules and Regulations implementing the Local Government Code of 1991 provides, that: *"xxx each Sanggunian concerned shall call all community-based People's Organization or NGO's including business and professional groups, and other similar aggrupation to apply with the LGU concerned for accreditation for membership in the Local Special Bodies"*;

WHEREAS, the BARANGAY 704, ZONE 77, DISTRICT V SENIOR CITIZENS ASSOCIATION is a duly registered organization certified by the Barangay Council as the official Senior Citizens Organization of Barangay 704, Zone 77, District V;

WHEREAS, the Association aims to promote the welfare of its members, unify the senior citizens of the barangay and to cooperate with the barangay in the implementation of its projects;

WHEREAS, the above-mentioned PO/NGO has substantially complied with the requirements prescribed by Article 64, as hereof stated;


WHEREAS, after due deliberation, the City Council found no legal impediment to accredit the said NGO/PO: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants accreditation in favor of Barangay 704, Zone 77, District V Senior Citizens Association, as an accredited People's Organization of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and forthwith issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished to the Office of the Mayor, the Department of the Interior and Local Government (DILG), the Manila Barangay Bureau (MBB) and the PO concerned.
