WHEREAS, the City Government of Manila has successfully completed the construction of several housing projects namely: Tondominium 1, Tondominium 2 and Binondominium which have been allocated to qualified informal settlers as part of a broader initiative to improve living conditions for all Manileños;

WHEREAS, the upcoming residential projects namely: Sebastian Residences, Pedro Gil Residences and San Lazaro Residences are scheduled for turnover within this year, marking a significant step forward in the city's urban development plans;

WHEREAS, recognizing the essential contributions and the challenging circumstances faced by the employees of the City Government of Manila, there is a pressing need to support their welfare through securing housing opportunities;
