**RESOLUTION GRANTING THE HONORABLE CITY MAYOR, MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, REPRESENTING THE CITY GOVERNMENT OF MANILA, THE AUTHORITY TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH - METRO MANILA CENTER FOR HEALTH DEVELOPMENT FOR THE IMPLEMENTATION OF THE MEDICAL ASSISTANCE TO INDIGENT AND FINANCIALLY INCAPACITATED PATIENTS PROGRAM (MAIFIP) UNDER SUB-ALLOTMENT ADVICE NO. 2023-08-004326, DATED AUGUST 29, 2023, IN THE AMOUNT OF THREE THOUSAND PESOS (PHP. 3,000.00) PER ELIGIBLE PATIENTS OF THE OSPITAL NG MAYNILA MEDICAL CENTER**

WHEREAS, on April 12, 2024, the City Council of Manila was in receipt of a letter from Atty. Marlon M. Lacson, Secretary to the Mayor, requesting for adoption of a resolution granting the Local Chief Executive, the authority, to enter into a Memorandum of Agreement (MOA) with the Department of Health - Metro Manila Center for Health Development (DOH-MMCHD), for the implementation of medical assistance to patients;


WHEREAS, the letter-request, together with the proposed MOA was referred to the City Council for appropriate action;

WHEREAS, Section 22(c) of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991, empowers the local chief executive to enter into contracts on behalf of the local government unit upon prior authorization by the Sanggunian concerned: NOW, THEREFORE, be it:

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, the authority to enter and sign into a Memorandum of Agreement with the Department of Health - Metro Manila Center for Health Development for the implementation of the Medical Assistance to Indigent and Financially Incapacitated Patients Program (MAIFIP) under Sub-Allotment Advice No. 2023-08-004326, dated August 29, 2023, in the amount of Three Thousand Pesos (PhP. 3,000.00) per eligible patients of the Ospital ng Maynila Medical Center; and be it FURTHER

RESOLVED, that the duly executed MOA to be entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
