LACUNA-PANGAN, MD, FPDS, THE AUTHORITY TO ENTER INTO AND SIGN FOR AND ON BEHALF OF THE CITY GOVERNMENT OF MANILA THE MEMORANDUM OF AGREEMENT WITH THE SINAG MAYNILA FOUNDATION, INC., REPRESENTED BY ITS CHAIRPERSON AND FOUNDER, MR. WILSON Y. TIENG, FOR THE IMPLEMENTATION OF SINAG MAYNILA FILM FESTIVAL

WHEREAS, the City Government of Manila recognizes the importance of promoting and supporting cultural and artistic initiatives that contribute to the development and enrichment of the city;

WHEREAS, Sinag Maynila Foundation, Inc. is a reputable organization committed to promoting Filipino culture and arts through various programs and activities, including film festivals;

WHEREAS, Sinag Maynila Foundation Inc. spearheaded the Sinag Maynila Film Festival, an event aimed at providing a platform for interested filmmakers to showcase their talents and creativity;

WHEREAS, the City Government of Manila and the Sinag Maynila Foundation, Inc. have mutually agreed to collaborate in organizing the Sinag Maynila Film Festival, intending to benefit both the residents of Manila and the broader filmmaking community, and to include this festival as a key event in the City of Manila's Tourism Month in September;

WHEREAS, the upcoming event is to be covered by a Memorandum of Agreement (MOA) which draft underwent the review of the City Legal Officer and recommended that authority be secured from the Sangguniang Panlungsod ng Maynila prior to the signing of the MOA: NOW, THEREFORE, be it



RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor Maria Sheilah "Honey" H.
