WHEREAS, Proclamation No. 1782 s. 2009 signed on May 21, 2009 by former President Gloria Macapagal Arroyo, declared June every year as the We Advocate Time Consciousness and Honesty (WATCH) month enjoining local government units and its educational institution to undertake specific activities in line with the observance the event every second week of June;


WHEREAS, the first whereas clause of the Proclamation states that "W.A.T.C.H (We Advocate Time Consciousness and Honesty) is an advocacy program jointly undertaken by JCI Senate Philippines, Department of Education, Commission on Higher Education, Technical Education and Skills Development Authority, Philippine Association of Colleges and Universities, PAPSCU, PRISAA and the Office of the Presidential Assistant for Education, to promote and undertake programs that will instill the value of punctuality and honesty in all sectors of society";


