
WHEREAS, on June 1, 2024 at 1:00 in the afternoon, a fire broke out and razed portions of Malaya St. Balut, Tondo, Manila, under the territorial jurisdiction of Barangay 125, Zone 10 and Barangay 142, Zone 12, District I, affecting ninety-five (95) families rendering three hundred forty-eight (348) individuals homeless;

WHEREAS, the Sangguniang Barangay, through Punong Barangay Angelina D. Paraon of Barangay 125, Zone 10 and Punong Barangay Mario Jose Sr. of Barangay 142, Zone 12, District I, requested the City Council that their barangays be declared as calamity areas to alleviate the needs of the victims: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to declare, as it hereby declares portions of Barangay 125, Zone 10 and Barangay 142, Zone 12, in the First District of Manila, which were razed by fire on June 1, 2024, as CALAMITY AREAS; and be it FURTHER

RESOLVED, that a copies of this Resolution be furnished to the above-mentioned barangays for legislative support purposes to facilitate the immediate release of their calamity funds.
