AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF ROSARITO, PALAWAN, DOMINGO SANTIAGO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (ROPADO TODA), INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

EXPLANATORY NOTE

The Rosarito, Palawan, Domingo Santiago Tricycle Operators and Drivers Association, Inc., is a duly registered corporation at the Security and Exchange Commission (SEC).

The said Association has met the routinary transportation requirements of commuters along the said route.

The operation of the said tricycle association will not create adverse effect on the smooth and orderly flow of traffic in the aforesaid area since the loading and unloading zones located at Domingo Santiago Street to España Street in Sampaloc, Manila, is within easy traffic control.

The enactment of this Ordinance will give a chance and equal opportunity to the members of the transport group to engage in tri-wheel business and certainly will empower them to become a responsible and productive members of the community.

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the Loading and Unloading areas of Rosarito, Palawan, Domingo Santiago Tricycle Operators and Drivers Association (ROPADO TODA), Inc., to read as follows:

“ROSARITO, PALAWAN, DOMINGO SANTIAGO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (ROPADO TODA), INC.

Loading and Unloading Areas

- a. Loading – Rosarito Street corner Visayan Avenue, Palawan Street corner Visayan Avenue and Domingo Santiago Street corner Visayan Avenue;
- b. Unloading – Blumentritt corner España Street, Altura Street corner Anonas Street and Sociego Street”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route lines of Rosarito, Palawan, Domingo Santiago Tricycle Operators and Drivers Association (ROPADO TODA), Inc., to read as follows:

“ASSOCIATION

50 Units

ROUTE

The authorized route lines of operation shall be via Rosarito Street – Palawan Street – Domingo Santiago Street – Blumentritt Street – Antipolo Street – Maceda Street – Altura Street – Anonas Street – Sociego Street vice-versa.”

SEC. 3. Separability Clause. – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.


SEC. 4. Repealing Clause. – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SEC. 5. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on June 20, 2024.


