### **ORDINANCE NO. 9065**

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF U-TOWN MANILA — DAPITAN TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, (UMDAPTODA) INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the Loading and Unloading areas of U-Town Manila – Dapitan Tricycle Operators and Drivers Association (UMDAPTODA), Inc., to read as follows:

## "U-TOWN MANILA - DAPITAN TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (UMDAPTODA), INC.

#### **Loading and Unloading Areas**

- a. Loading Dapitan Street corner Gelinos Street and Dapitan Street corner V. Concepcion Street;
- b. Unloading Legarda Street corner Earnshaw Street, R. Papa Street, S.H. Loyola Street corner P. Noval Street, M.F Jhocson Street, S.H. Loyola Street corner Vicente Cruz, S.H. Loyola Street corner Maceda Street and Fajardo Street corner M. Dela Fuente Street"
- **SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route lines of U-Town Manila Dapitan Tricycle Operators and Drivers Association (UMDAPTODA), Inc. to read as follows:

#### "ASSOCIATION

R.M.C.

U-Town Manila – Dapitan Tricycle Operators and Drivers Association (UMDAPTODA), Inc.

50 Units

#### ROUTE

The authorized route lines of operation shall be via Dapitan Street – P. Noval Street – S.H. Loyola Street – Vicente Cruz Street – R. Papa Street – Earnshaw Street – M.F Jhocson Street – Legarda Street – M. Dela Fuente Street – Maceda Street and vice-versa."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- **SEC. 4. Repealing Clause.** All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
- **SEC. 5. Effectivity Clause.** This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on June 25, 2024.
