RESOLUTION ENCOURAGING A FULL SWING PUBLIC AWARENESS CAMPAIGN ON THE ILL-EFFECTS OF SMOKING COINCIDING WITH THE OBSERVANCE OF THE "NATIONAL NO SMOKING MONTH" THIS JUNE 2024

WHEREAS, Proclamation No. 183 issued on May 30, 1993 declared the month of June every year as the "National No Smoking Month" in the country and observed with three main focuses:

- 1. Absolute smoking ban inside and outside school premises;
- Prohibition of sale of cigarettes and other tobacco products within 100 meters from any point of the perimeter of a school, playground or other facility frequented by minors; and
- 3. Advocacy to parents and family members on not instructing children to buy or light tobacco products for them;

WHEREAS, the observance centers on the protection of well-being of the youth against the harmful effects of smoking or from being exposed to secondhand smoke;

WHEREAS, to further promote and advocate a smoke-free environment, especially to the youth, Executive Order No. 26 commonly known as the "Nationwide Smoking Ban" was issued in relation to Republic Act No. 9211, otherwise known as the "Tobacco Regulation Act of 2003" to ensure that persistent reminders of the long-term illeffects of tobacco are provided for public information: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to encourage, as it is hereby encourages a full swing public awareness campaign on the ill-effects of smoking coinciding with the observance of the "National No Smoking Month" this June 2024; and be it FURTHER

RESOLVED, that copies of this Resolution be furnished to the Manila Public Information Office (MPIO) for online dissemination.

WHEREAS, Catholic Relief Services - United States Conference of Catholic Bishops (CRS-USCCB) is implementing the Clean Manila, Blue Bay (CMBB) Project Phase 2, through the financial support of Tetra Tech, the implementing arm of the United States Agency for International Development - Clean Cities, Blue Ocean Program (USAID-CCBO), which aims to reduce plastic pollution in marine environments in the City of Manila;

WHEREAS, CRS-USCCB aims to support the capacity building and strengthening of the City of Manila and the six (6) project-supported barangays in the City of Manila, namely: Barangay 91, 93, 98, 105, 118 and 128, in the field of solid waste management, through the CMBB Project;

WHEREAS, for the purpose of achieving certain objectives of improving local policy implementation, the parties authorized by this Resolution have entered into a Memorandum of Understanding to collaborate on activities that would capacitate enforcement units for the strict implementation of environmental policies and improvement of solid waste management in the City of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Government of Manila to ratify, as it hereby ratifies the Memorandum of Understanding entered into by and between the City Government of Manila and the Catholic Relief Services - United States Conference of Catholic Bishops for the establishment and implementation of solid waste policies and others, duly executed on June 18, 2024 in the City of Manila; and be it FURTHER
