RESOLUTION GRANTING ACCREDITATION IN FAVOR OF PANGANIBAN INTERIOR NEIGHBORHOOD ASSOCIATION FOR URBAN POOR INC., AS AN ACCREDITED PEOPLE'S ORGANIZATION OF THE CITY OF MANILA

WHEREAS, PANGANIBAN INTERIOR NEIGHBORHOOD ASSOCIATION FOR URBAN POOR INC., with office address at 1898 J.H. Panganiban Street, Sta. Mesa, Manila, a duly registered organization with the Securities and Exchange Commission (SEC), is seeking accreditation as a registered People's Organization (PO);

WHEREAS, the Association aims to contribute in the upliftment and development of the quality of life, not only of its members but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs designed to promote self-reliance and economic independence;

WHEREAS, the Association's other purposes are as follows:

1. To initiate and promote a healthy and harmonious neighborhood by developing the civic, spiritual, cultural and social awareness and consciousness of its members;
2. To conduct and sponsor seminars, symposia and technical training to be conducted by expert trainers and resource speakers;
3. To promote and maintain peace and order as well as cleanliness in the community in coordination with the proper government agencies;
4. To act as intermediary with the different government agencies tasked with the delivery of basic necessities and services to the community;
5. To seek assistance and guidance of government and private institutions necessary to achieve the full realization of the association's objectives;
6. To organize and undertake workshops for livelihood projects and other socio-economic activities, for the benefit of its members; and
7. To do and perform all other acts and deeds as may be necessary, convenient and appropriate for the accomplishment of the foregoing purposes;

WHEREAS, the same organization submitted the accomplished requirements and supporting documents for purposes of accreditation;



RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and forthwith issued to the said association; and be it FINALLY


RESOLVED, that copies of this Resolution be furnished the Department of the Interior and Local Government (DILG) and the PO concerned.
