WHEREAS, in a letter dated 30 May 2024 to the leadership of this Sanggunian, the Secretary to the Mayor Atty. Marlon M. Lacson, requested for the adoption of a resolution granting the Local Chief Executive the authority to enter into a Memorandum of Agreement (MOA) for work immersion partnership consistent with Republic Act No. 10533, otherwise known as "Enhanced Basic Education Act of 2013";

WHEREAS, the letter-request, together with the proposed MOA, was referred to the City Council for appropriate action;



RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor, Maria Sheilah "Honey" Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, the authority to enter into a Memorandum of Agreement with Salian Foundation, Inc., for Work Immersion Partnership; and be it FURTHER
