RESOLUTION GRANTING THE HONORABLE CITY MAYOR, MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, REPRESENTING THE CITY GOVERNMENT OF MANILA, THE AUTHORITY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD), THROUGH THE HEALTH FACILITIES ENHANCEMENT PROGRAM (HFEP), FOR THE UPGRADING, REHABILITATION, REPAIR, CONSTRUCTION AND/OR COMPLETION OF THE HEALTH CENTERS IN THE CITY OF MANILA, PARTICULARLY TONDO HEALTH CENTER AMOUNTING TO TEN MILLION PESOS (PHP. 10,000,000.00), M. EARNSHAW HEALTH CENTER, AMOUNTING TO TEN MILLION PESOS (PHP. 10,000,000.00), PALTOC HEALTH CENTER, AMOUNTING TO TEN MILLION PESOS (PHP. 10,000,000.00) AND JOSE VICENCIO HEALTH CENTER, AMOUNTING TO TEN MILLION PESOS (PHP. 10,000,000.00)

Marlon Lacson, requested for adoption of a resolution granting authority to the Local Chief Executive to enter into a Memorandum of Agreement (MOA) for the upgrading, rehabilitation, repair, construction and/or completion of the following health centers in the City of Manila namely:

1. Tondo Health Center
2. M. Earnshaw Health Center
3. Paltoc Health Center; and
4. Jose Vicencio Health Center


WHEREAS, the letter-request, together with the proposed MOA was referred to this Sanggunian for appropriate action;

WHEREAS, Section 22(c) of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991, empowers the Local Chief Executive to enter into contracts on behalf of the local government unit upon prior authorization by the sanggunian concerned: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, the authority to enter into a Memorandum of Agreement with the Department of Health-Metro Manila Center for Health Development (DOH-MMCHD), through the Health Facilities Enhancement Program (HFEP), for the upgrading, rehabilitation, repair, construction and/or completion of the health centers in the City of Manila particularly Tondo Health Center, amounting to Ten Million Pesos (Php. 10,000,000.00), M. Earnshaw Health Center, amounting to Ten Million Pesos (Php. 10,000,000.00), Paltoc Health Center, amounting to Ten Million Pesos (Php. 10,000,000.00) and Jose Vicencio Health Center, amounting to Ten Million Pesos (Php. 10,000,000.00); and be it FURTHER


RESOLVED, that the duly executed MOA entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
