RESOLUTION CONGRATULATING MS. MARA BLESSIAH KATIGBAK BAYBAY FOR HER EXEMPLARY PERFORMANCE IN THE SPECIAL PROFESSIONAL LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS – SECONDARY, HELD ON JUNE 18, 2024, SECURING THE SECOND SPOT AMONG THE TOPNOTCHERS IN THE SAID EXAMINATION WITH A RATE OF 89.80%

WHEREAS, the Pamantasan ng Lungsod ng Maynila (PLM) is the first and only chartered and autonomous university funded by the city government, created by virtue of Republic Act No. 4196 entitled: "An Act Authorizing the City of Manila to Establish and Operate the University of the City of Manila and for Other Purposes" signed into a law on June 19, 1965;

WHEREAS, on June 18, 2024 the Board of Professional Teachers under the supervision of the Professional Regular Commission (PRC) conducted the Special Professional Licensure Examination for Professional Teachers in several testing centers around the middle eastern countries;

WHEREAS, Ms. Mara Blessiah Katigbak Baybay, a graduate of Bachelor of Science in Biology at the PLM – Department of Biology College of Science was one of the examinees in the aforesaid licensure examination;


WHEREAS, the regulatory agency for professionals recently announced that out of the four hundred seventy-eight (478) examinees, two hundred fifty-two (252) or 52.72% hurdled the licensure examination for secondary teachers and among the topnotchers is an alumna of the PLM named Ms. Mara Blessiah Katigbak Baybay;

WHEREAS, the premiere learning institution of the city has consistently produced competent graduates who have greatly contributed for the betterment not only of the city, but the whole country as well: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to congratulate, as it hereby congratulates Ms. Mara Blessiah Katigbak Baybay for her exemplary performance in the Special Professional Licensure Examination for Professional Teachers – Secondary, held on June 18, 2024, securing the second spot among the topnotchers in the said examination with a rate of 89.80%; and be it FURTHER
