## **RESOLUTION NO. 486**

RESOLUTION ADOPTING JOINT BARANGAY RESOLUTION TO TEMPORARILY DESIGNATE CERTAIN PORTIONS ALONG STRETCH OF ALGECIRAS STREET UNDER THE JURISDICTION OF BARANGAYS 446, 444, 443, 442 & 450, ZONES 44 AND 45, DISTRICT IV, MANILA, AS A ONE (1) SIDE PARKING NORTH BOUND LEFT SIDE BETWEEN G. TUAZON UP TO S.H. LÓYOLA STREETS AND BETWEEN S.H. LOYOLA AND ESPAÑA STREETS AS A TWO SIDE PARKING THEREOF AS A SAFETY PRECAUTION AND IN ORDER TO ENSURE SMOOTH FLOW OF TRAFFIC IN THE AREA, THAT IS FREE FROM ANY KIND OF OBSTRUCTION AS ENUNCIATED UNDER R.A. 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991, AND FOR OTHER PURPOSES

WHEREAS, there is an ongoing national railway improvement project in some portions of District IV, Sampaloc, Manila, spearheaded by the Department of Transportation and Railways (DOTR) more specifically along the stretch of Algeciras Street in the areas covered by Barangay 446, 444, 443, 442 and 450;

WHEREAS, inasmuch as time is of the essence due to the installation by DOTR of concrete barriers and steel fences along the area, the entire affected stretch of Algeciras Street became narrower and thus, it is imperative to institute such remedial measures thereof so as to ensure a smoother flow of traffic in the area and as a means of safety precaution:

WHEREAS, there is a need to temporarily designate certain portions of the stretch of Algeciras Street specifically under the jurisdiction of Barangay 446, 444, 443, 442 and 450 as One-Side Parking North Bound Left Side between G. Tuazon up to S.H. Loyola Streets (residential parking) and between S.H. Loyola and España Streets (e-trike charging station) as Two Side Parking thereof as a safety precaution and in order to ensure a better and smoother flow of traffic in the area: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to adopt, as it is hereby adopts, Joint Barangay Resolution to temporarily designate certain portions along stretch of Algeciras Street under the jurisdiction of Barangays 446, 444, 443, 442 & 450, Zones 44 and 45, District IV, Manila, as a One Side Parking North Bound Left Side between G. Tuazon up to S.H. Loyola Streets and between S.H. Loyola and España Streets as a Two Side Parking thereof as a safety precaution and in order to ensure smooth flow of traffic in the area, that is free from any kind of obstruction as enunciated under R.A. 7160 otherwise known as the Local Government Code of 1991, and for other purposes.
