RESOLUTION GRANTING THE HONORABLE CITY MAYOR, MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, REPRESENTING THE CITY GOVERNMENT OF MANILA, THE AUTHORITY TO SIGN THE DEED OF DONATION WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-BIODIVERSITY MANAGEMENT BUREAU (DENR-BMB) FOR THE DONATION OF THE WILDLIFE SPECIES TO THE MANILA ZOOLOGICAL AND BOTANICAL GARDEN

WHEREAS, in a letter dated 4 July 2024, the Secretary to the Mayor, Atty. Marlon M. Lacson requested for adoption of a resolution granting the Local Chief Executive to sign the Deed of Donation with the Department of Environment and Natural Resources-Biodiversity Management Bureau (DENR-BMB), involving wildlife species to the Manila Zoological and Botanical Garden, to wit:


WHEREAS, the letter comes with a draft instrument which underwent review by the City Legal Officer, who found the same to be generally in order and interposed no objection for approval and signature of the Honorable Mayor;

WHEREAS, Section 22(c) of Republic Act (R.A.) No. 7160 otherwise known as the Local Government Code of 1991, empowers the local chief executive to enter into contracts on behalf of the local government unit upon prior authorization by the sanggunian concerned: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, the authority to sign the Deed of Donation with the Department of Environment and Natural Resources-Biodiversity Management Bureau (DENR-BMB) for the donation of the wildlife species to the Manila Zoological and Botanical Garden; and be it FURTHER
