AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of DISTRICT V TODA MANILA BRGY. 649 BASECO INC., to read as follows:

"DISTRICT V TODA MANILA BRGY, 649 BASECO INC.

Loading and Unloading Areas

- a. Amadome, Main Road Baseco Compound;
- b. Pier South corner Mel Lopez Boulevard; and
- c. Divisoria comer Recto Avenue."

SEC. 2. Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of DISTRICT V TODA MANILA BRGY. 649 BASECO INC., to read as follows:

ROUTE

The authorized route lines of operation for "DISTRICT V TODA MANILA BRGY. 649 BASECO INC.", shall be via Amadome, Main Road Baseco Compound to Pier South, Pier South to Divisoria and vice-versa."

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on November 28, 2023.
