AN ORDINANCE AMENDING CITY ORDINANCE NO. 8591, ENTITLED: "AN ORDINANCE ESTABLISHING THE MANILA TOURISM, CULTURE AND ARTS COUNCIL AND PROVIDING FUNDS THEREOF"

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2 of City Ordinance No. 8591 is hereby amended to read as follows:

“SEC. 2. Composition. –

Chairman:

- City Mayor of Manila

Vice Chairperson/s:

- Chairperson of Committee on Tourism, Arts and Culture
- Head of the Department of Tourism, Culture and Arts of Manila

Members:

- Local Planning and Development Officer
- Local Information Officer
- Local Budget Officer
- Local Legal Officer
- Local Engineer
- Representative of the Department of Education (DEPED)–Manila
- Representative of the Department of Interior and Local Government (DILG)–Manila
- Representative of the Department of Tourism (DOT)–Regional Office
- Representative of Manila Barangay Bureau
- Representative of Liga ng mga Barangay
- Representative of the Parks Development Office
- Representative of Manila Police District (MPD)
- Representative of the Department of Environment and Natural Resources (DENR)
- Representative of the Business Sector
- Representative of the Local Artists Group
- Representative of the National Commission for Culture and the Arts (NCCA)
- Representative of the Manila Disaster Risk Reduction Office (MDRRO)
- Representative of the National Historical Commission of the Philippines (NHCP)
- Representative of the National Museum
- Representative of the Intramuros Administration
- Representative of the National Parks Development Committee

The role of the National Government Agencies (NGA) shall be advisory in nature, except for the NCCA, NHCP and National Museum which play vital roles in the implementation of Republic Act No. 10066, otherwise known as the National Cultural Heritage Act of 2009.

SEC. 2. Section 3 of City Ordinance No. 8591 is hereby amended to read, as follows:

“SEC. 3. Duties and Functions. --

a. – n. xxx

o. Empowered to create a funding source for its projects.”

SEC. 3. Section 4 of City Ordinance No. 8591 is hereby amended to read, as follows:

“SEC. 4. Funding. –


An amount of Two Million Pesos (PhP. 2,000,000.00) from the budget of the local tourism, culture and arts department will be initially appropriated in order to carry out the purposes of this Ordinance without prejudice to any augmentation as the needs arise.

Thereafter, the Council is hereby authorized to source funds and generate income from its own activities and programs and from other possible external sources which it may receive in the form of grants, donations, gifts and assistance from local and international public and private institutions, groups, organizations and individuals.”

SEC. 4. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on August 29, 2024.


