RESOLUTION AMENDING RULE XIX, SECTION 87 OF THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG PANLUNGSOD NG MAYNILA, AS AMENDED, AND FOR OTHER PURPOSES

WHEREAS, the Sangguniang Panlungsod ng Maynila adopted its Internal Rules of Procedure on July 4, 2022 by virtue of Resolution No. 112, Series of 2022, pursuant to and in accordance with the provisions of Sec. 50, Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Rule XXVII of the Internal Rules of Procedure states that the same may be amended or revised by two-thirds (2/3) votes of all the members of the Sanggunian, duly elected and qualified, but only after the lapse of six (6) months from the date of its adoption;

WHEREAS, in the maintenance of good order in deliberations, this Sanggunian deems imperative to amend its existing Internal Rules of Procedure in the interest of effective legislation;

WHEREAS, Rule XIX, Section 37 in the Internal Rules of Procedure is hereby amended, and shall be read as:


“SIMPLE MAJORITY- Except as otherwise provided in the Internal Rules of Procedure and existing laws, rules and regulations, a vote by a mere simple majority shall prevail on other measures, motions or propositions, including motion to suspend the rules, provided there is a quorum. In parliamentary parlance, the term simple majority means one-half plus one (1/2 + 1) of the total votes cast by the members present there being a quorum. It might be less than the majority of the entire membership”:

NOW, THEREFORE be it

RESOLVED, by the Sangguniang Panlungsod ng Maynila to amend, as it hereby amends Rule XIX, Section 37 of the Internal Rules of Procedure of the Sangguniang Panlungsod ng Maynila, as amended, and for other purposes; and be it FURTHER


RESOLVED, that copies of this Resolution be distributed to all City Councilors.
