WHEREAS, a draft Memorandum of Understanding (MOU) has reached the consideration of this Sanggunian between the City Government of Manila and the Department of Social Welfare and Development (DSWD) for the implementation of the Cash and Food-for-Work, Training and Caring (C/FFW/T/C) for Disaster Risk Reduction and Management;


WHEREAS, the draft instrument underwent the review of the City Legal Officer, emanated from the Public Employment Service Office, who found the same to be generally in order and raised no objection to the approval and signature of the Honorable Mayor;

WHEREAS, Section 22(c) of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991, empowers the local chief executive to enter into contracts on behalf of the local government unit upon prior authorization by the sanggunian concerned: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor, Maria Sheilah "Honey" H.
