RESOLUTION ADOPTING AND APPROVING RESOLUTION NO. 4, SERIES OF 2024, PASSED BY THE EXECUTIVE COMMITTEE OF THE CITY DEVELOPMENT COUNCIL, ENTITLED: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2024 IN RELATION TO THE INCREASE IN THE COMPENSATION RATE FOR CONTRACT OF SERVICE PERSONNEL AND JOB ORDER WORKERS OF THE CITY OF MANILA REQUIRING THE AUGMENTATION OF THE OTHER GENERAL SERVICES ACCOUNT IN THE TOTAL AMOUNT OF SEVENTY-ONE MILLION SEVEN HUNDRED FOUR THOUSAND PESOS (P 71,704,000.00)"

WHEREAS, Section 106 of Republic Act No. 7160 otherwise known as the Local Government Code (LGC) of 1991, provides that each local government unit (LGU) shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its *sanggunian*;

WHEREAS, the Executive Committee of the City Development Council was convened in the exigency of the service, prompted by the need to appraise and prioritize socio-economic development programs and projects of the City of Manila;

WHEREAS, Section 16 of the LGC mandates LGUs to promote the general welfare, education, health and safety of its constituents; enhance economic prosperity and social justice; and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 336 of the LGC provides that funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the *sanggunian* concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;


WHEREAS, in line with the promotion of the general welfare of the residents of Manila, there is a need to amend the annual investment program and issue a supplemental investment program for FY 2024 to cover the additional requirements for the increase of Two Thousand Pesos (PhP. 2,000.00) per month in the compensation rate of Contract of Service (COS) Personnel and Job Order (JO) Workers under the Other General Services account in order to help mitigate the impact of inflation and to ensure that they can meet their daily basic needs while considering availability of funds;

RESOLVED, by the City Council of Manila to adopt and approve, as it hereby adopts and approves Resolution No. 4 Series of 2024, passed by the Executive Committee of the City Development Council, entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2024 IN RELATION TO THE INCREASE IN THE COMPENSATION RATE FOR CONTRACT OF SERVICE PERSONNEL AND JOB ORDER WORKERS OF THE CITY OF MANILA REQUIRING THE AUGMENTATION OF THE OTHER GENERAL SERVICES ACCOUNT IN THE TOTAL AMOUNT OF SEVENTY-ONE MILLION SEVEN HUNDRED FOUR THOUSAND PESOS (₱ 71,704,000.00)"; and be it FURTHER

RESOLVED, that Resolution No. 4, Series of 2024, passed by the Executive Committee of the City Development Council on August 22, 2024 be made part of this Resolution.
