RESOLUTION MANIFESTING THE CONCURRENCE OF THE CITY COUNCIL OF MANILA TO THE APPOINTMENT OF ATTY. MARISOL DL. ANENIAS, AS MEMBER OF THE BOARD OF REGENTS, PAMANTASAN NG LUNGSOD NG MAYNILA, EFFECTIVE ON AUGUST 16, 2024 TO AUGUST 15, 2030

WHEREAS, Sub-section (a), Article 119 (Appointive Local Officials) of the implementing rules and regulations of R.A. 7160 (Local Government Code of 1991), states that: "unless otherwise provided in this Rule, heads of offices and departments in the LGU's shall be appointed by the local chief executive concerned with the concurrence of a majority of all the members of the sanggunian, subject to civil service laws, rules and regulations";

WHEREAS, Section 4 of Republic Act No. 4196 vested the power to appoint the members of the Board of Regents to the mayor of the City of Manila with consent of the Municipal Board, now the City Council of Manila;

WHEREAS, Atty. Anenias had served the Pamantasan ng Lungsod ng Maynila from 2007 to 2018 having occupied the following positions:

- Dean, College of Law: 2015 2018
- Associate Dean, College of Law: 2009 2015
- College Secretary, College of Law: 2007 2009
- Secretary to the Board of Regents: 2007 2009
- University Secretary: 2007 2009

WHEREAS, through the leadership of Atty. Anenias as the Dean of the College of Law, Pamantasan ng Lungsod ng Maynila achieved the following citations during her term:

- Top 10 Law School Awardee 2017
- 1st Ranking Law School in the Bar Examinations 2016
- Center of Excellence Award 2015

WHEREAS, after a careful study and evaluation of the appointee's qualifications and other pertinent documents, the City Council of Manila finds that she is highly qualified to occupy the position: NOW THEREFORE, be it:

RESOLVED, by the City Council of Manila to manifest, as it hereby manifests the concurrence of the City Council of Manila to the appointment of Atty. Marisol DL. Anenias, as a member of the Board of Regents, Parnantasan ng Lungsod ng Maynila, effective August 16, 2024 to August 15, 2030.
