RESOLUTION GRANTING THE APPLICATION FOR THE RENEWAL OF SPECIAL USE PERMIT BEING A REQUIREMENT FOR THE ISSUANCE OF BUSINESS PERMIT IN FAVOR OF SEAOIL PHILIPPINES, INC., FORMERLY KNOWN AS ASIA LAND POWER PETROLEUM COMPANY, INCORPORATED, LOCATED AT 2826 JOSE ABAD SANTOS AVENUE, TONDO, MANILA

WHEREAS, pursuant to Section 3 of Ordinance No. 8341, entitled: "AN ORDINANCE AMENDING CERTAIN ADMINISTRATION AND ENFORCEMENT PROVISIONS OF ARTICLE XI OF ORDINANCE NO. 8119, OTHERWISE KNOWN AS THE MANILA COMPREHENSIVE LAND USE PLAN AND ZONING ORDINANCE OF 2006", the issuance of Special Use Permit shall be a condition *sine qua non* for the issuance of business permit;

WHEREAS, pursuant to Section 1 of Ordinance No. 8341, all applications for the issuance of Special Use Permit for all conforming uses, regardless on whether it is a new application or a renewal thereof, shall be filed with the City Planning and Development Office which shall then forward the same to the Sangguniang Panlungsod ng Maynila for approval. The City Planning and Development Officer shall not issue any special use permits unless and until a resolution approving the application is issued by the Sangguniang Panlungsod ng Maynila;

WHEREAS, SEAOIL PHILIPPINES, INC., applied for the renewal of a Special Use Permit before the City Planning and Development Office (CPDO) and was forwarded to the Sangguniang Panlungsod ng Maynila for consideration: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the application for the renewal of Special Use Permit being a requirement for the issuance of Business Permit in favor of SEAOIL PHILIPPINES, INC., formerly known as Asia Land Power Petroleum Company, Incorporated, located at 2826 Jose Abad Santos Avenue, Tondo, Manila; and be it FURTHER

RESOLVED, that a copy of this Resolution be furnished the City Planning and Development Office (CPDO) of the City of Manila.
