
WHEREAS, in a letter dated 20 September 2024, the Secretary to the Mayor, Atty. Marlon M. Lacson, requested for the passage of a resolution granting authority to the Chief Executive of the City to enter into a contract of affiliation with the Philippine Rehabilitation Institute (PRI) Foundation, Inc. for the training of its nursing students at Gat. Andres Bonifacio Medical Center;

WHEREAS, a similar request has passed the scrutiny of the City Legal Officer before who opined that such draft contract of affiliation and the undertakings specified therein are consistent with the City Government of Manila's exercise of powers under the General Welfare Clause, specifically Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991. However, she recommended that prior authority from the City Council must first be secured before the City Mayor is made to sign the agreement on behalf of the city;

WHEREAS, the draft contract of affiliation has reached the consideration of the policy-making body and after a brief discussion and deliberation, agreed to approve the request: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, authority to enter into a contract of affiliation with the Philippine Rehabilitation Institute (PRI) Foundation, Inc. for the training of its students in the field of Nursing at Gat. Andres Bonifacio Medical Center.
