
WHEREAS, the letter-request, together with the proposed MOA was referred to the City Council for appropriate action;

WHEREAS, the draft MOA has earned the consideration of the policy-making body and after a brief discussion, reached a consensus to approve the request: NOW THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, the authority to enter into a Memorandum of Agreement with the National Nutrition Council regarding the implementation of the Dietary Supplementation Program for pregnant women and children 6-23 months old; and be it FURTHER

RESOLVED, that the duly executed MOA entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
