RESOLUTION GRANTING THE HONORABLE CITY MAYOR, MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, REPRESENTING THE MANILA ANTI-DRUG ABUSE OFFICE (MADAO) UNDER THE CITY GOVERNMENT OF MANILA, AUTHORITY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH - MEGA DRUG ABUSE TREATMENT AND REHABILITATION CENTER (DOH-MEGA DATRC) ENABLING THE ACCREDITATION OF A TREATMENT AND REHABILITATION FACILITY

WHEREAS, a draft Memorandum of Agreement (MOA) between an attached agency of the Department of Health and the City Government of Manila has reached the consideration of this Sanggunian relative to the accreditation of a treatment and rehabilitation facility for victims of drug abuse;

WHEREAS, the proposed MOA shall provide treatment and rehabilitation to drug dependents on voluntary submission to confinement including indigent dependents who are residents of the City of Manila;


WHEREAS, the proposed instrument underwent review by the City Legal Officer who stated that it is in accord with Section 51 of Republic Act No. 9165, otherwise known as the "Comprehensive Dangerous Drugs Act of 2002" to the effect that the City of Manila is giving priority to a preventive educational program and the rehabilitation or treatment of drug dependent constituents of the city;

WHEREAS, the City Legal Officer further stated that stipulations under the proposed MOA are favorable to the City of Manila as the same are not contrary to laws, city ordinances, rules and regulations, good morals, public policy and public order: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, representing the Manila Anti-Drug Abuse Office (MADAO) under the City Government of Manila, authority to enter into a memorandum of agreement with the Department of Health - Mega Drug Abuse Treatment and Rehabilitation Center (DOH-Mega DATRC) enabling the accreditation of a treatment and rehabilitation facility; and be it FURTHER

RESOLVED, that the duly executed MOA to be entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
