**AN ORDINANCE** ABOLISHING THREE (3) VACANT POSITIONS IN THE JUSTICE JOSE ABAD SANTOS GENERAL HOSPITAL BY WAY OF SCRAP-AND-BUILD TO GIVE WAY TO THE CREATION OF MORE ESSENTIAL POSITIONS

## **EXPLANATORY NOTE**


Section 325(d) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that in cases of abolition of existing positions in the career service, such abolition or creation shall be made in accordance with pertinent provisions of this Code and civil service laws, rules and regulations.

Furthermore, Section 76 of the same act provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

The Justice Jose Abad Santos General Hospital (JJASGH), headed by Office-In-Charge – Hospital Director Merle Sacdalan-Faustino and through the unwavering service and dedication of the hospital personnel, continue to attend to the medical needs of the people especially those of the residents of the City of Manila.

JJASGH currently has five hundred fifty-nine (559) plantilla positions. However, upon review and reassessment of the hospital's staffing pattern, there is a need abolish and create some positions that would better address the needs of the institution.

In view of the foregoing, the approval of this Ordinance is earnestly sought.

Be it ordained by the City Council of Manila, in session assembled, THAT:

**SECTION 1. Declaration of Policy.** – It is hereby declared the policy of the City Government of Manila to faithfully observe the overriding goal of improving the delivery of vital services in terms of quality, scope, speed, accountability, and affordability.

The city and its instrumentalities must promote focused use of limited resources on core functions and programs, while simultaneously cutting and scaling-down, phasing-out or abolishing non-core tasks.

**SEC. 2. Abolished Plantilla Positions.** – The following positions are hereby abolished in the Justice Jose Abad Santos General Hospital (JJASGH):

**SEC. 3. New Plantilla Positions.** – The following new plantilla items are hereby created in the Justice Jose Abad Santos General Hospital (JJASGH):

**SEC. 4. Qualifications, Powers, and Duties/Responsibilities.** – The qualifications, powers, duties, and responsibilities of the herein enumerated positions shall be based on the provisions of the Local Government Code, civil service laws, rules and regulations and other relevant issuances.

**SEC. 5. – Appointment.** – The employment and appointment of the individuals for the herein subject positions shall be within the prescribed qualification standards and guidelines set by the Civil Service Commission (CSC), and other relevant agencies.


**SEC. 6. Appropriations.** – The amount necessary for the creation of three (3) new plantilla positions shall be derived from the available savings generated from the three (3) abolished vacant items in the 2023 Executive Budget. Thereafter, the herein subject new positions shall be automatically funded through the succeeding Annual City Budget as part of the Plantilla Personnel of the Justice Jose Abad Santos General Hospital (JJASGH).

**SEC. 7. Repealing Clause.** – Any provision of ordinances, executive orders, issuances or rules and regulations inconsistent with the provisions of this Ordinance is hereby repealed, amended, or modified accordingly.

**SEC. 8. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on May 16, 2024.


