ORDINANCE NO. 9091

AN ORDINANCE EXEMPTING FROM PAYMENT OF TRANSPORT FARE IN RIDING CITY-OPERATED E-TRIKE VEHICLES OF ALL THE SENIOR CITIZENS AND PERSONS WITH DISABILITIES (PWDs) CURRENTLY RESIDING IN THE CITY OF MANILA, AND PROVIDING DISCOUNT RATES TO ALL STUDENTS CURRENTLY ENROLLED IN EDUCATIONAL INSTITUTIONS WITHIN THE CITY OF MANILA

EXPLANATORY NOTE

It is the policy of the City Government of Manila to recognize the rights of senior citizens, PWD's and all City of Manila Students of their contribution in nation-building.

The Office of the Manila Traffic and Parking Bureau (MTPB) has formally endorsed to the Committee on Transportation regarding the Fare Matrix of E-Trike Vehicle in the City of Manila.

All senior citizens, PWDs and students must present their respective IDs to E-Trike Driver to avail the free Fare Payment.

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Short Title. – This Ordinance shall be known as the "2024 Senior Citizens Free E-Trike Rides and Students Discounted E-Trike Rides Ordinance", for brevity.

SEC. 2. Declaration of Policy. – It shall be the policy of the City of Manila to give priority in providing basic services to the elderly and differently-abled persons and also to students.

SEC. 3. Scope of Coverage. – Senior Citizen residents in the City of Manila shall be exempted from paying transport fares in e-trike vehicles and students enrolled in educational institutions shall be provided a 20% discount.


SEC. 4. Penalties. – The following penalties shall be imposed on drivers and operators of e-trike vehicles for violation of this Ordinance:

1 st Offense	- Two Thousand Pesos (PhP2,000.00)
2 nd Offense	- Three Thousand Pesos (PhP3,000.00)
3 rd Offense	- Five Thousand Pesos (PhP5,000.00) and Revocation of rights to drive or operate an E-trike Vehicle

SEC. 5. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on December 10, 2024.
