

Lacson, Secretary to the Mayor, requesting for adoption of a resolution ratifying the Memorandum of Agreement (MOA) between the City Government of Manila – Manila Health Department represented by Honorable City Mayor Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS and the Médecins Sans Frontières (MSF) - Philippine Office, for the implementation of the Project "Support to Diagnosis and Treatment of Tuberculosis in Tondo Districts 1 and 2, City of Manila, Philippines";
