EXPLANATORY NOTE

Ordinance No. 9075 or the FY 2025 Annual Executive Budget included the project, entitled: "Completion of Ten (10) Storey Kalinga sa Maynila Center" under the Special Purpose Appropriations.

However, the Department of Engineering and Public Works (DEPW) requested the change of project title from "Completion of Ten (10) Storey Kalinga sa Maynila Center" to "Continuation of Ten (10) Storey Kalinga sa Maynila Center (Phase II)" while maintaining the same approved budget under the FY 2025 Annual Budget.

The Department of Engineering and Public Works (DEPW) deemed it necessary due to revision in the structural design, particularly in the foundation works of the building, which has impacted the overall project scope of works. The changes are essential to ensure the structural integrity and long-term stability of the facility, aligning with the safety standards and engineering best practices.

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. The project title of a project included under the Special Purpose Appropriations of the FY 2025 Executive Budget is hereby amended to read as follows:

SEC. 2. Amendatory and Repealing Clause. – All local ordinances, resolutions, rules and regulations or part thereof that are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SEC. 3. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.
