WHEREAS, in a letter dated February 10, 2025, the Secretary to the Mayor, Atty. Marlon M. Lacson, requested for the adoption of a resolution granting the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Golden Donuts, Inc. (Dunkin Donuts), for the employment of senior citizens and persons with disabilities (PWDs);


WHEREAS, the letter-request, together with the proposed Memorandum of Agreement (MOA), was referred to the City Council for appropriate action;

WHEREAS, Section 22(c) of Republic Act (R.A.) No. 7160 otherwise known as the Local Government Code of 1991, empowers the local chief executive to enter into contracts on behalf of the local government unit upon prior authorization by the Sanggunian concerned: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the Honorable City Mayor, Maria Sheilah "Honey" H.
