WHEREAS, former Councilor Atty. Nemesio C. Garcia, Jr., was born on the 6th of May 1942;

WHEREAS, he studied at Espiritu Santo Parochial School and at San Beda College, where he finished his Bachelor of Arts in Philosophy in 1962 and Bachelor of Laws in 1966;

WHEREAS, he was a former Senior Associate at Juan T. David Law Office and as a trial lawyer for 21 years, he handled criminal, civil, labor, administrative, customs and election cases;

WHEREAS, during his time as a lawyer, he also became the campaign manager of his late brother-in-law, Congressman Leonardo "Nading" Fugoso. He is also the uncle of Manila Department of Social Welfare Officer-in-Charge, Ma. Asuncion "Re" G. Fugoso and Councilor, Pamela "Fa" G. Fugoso-Pascual;

WHEREAS, in 1988, Councilor Atty. Garcia ran for and won as Councilor in the Third District of Manila, committing himself as a respected member of the 1st Manila City Council where he was appointed as the Chairman of the Committee on Laws, Vice-Chairman of the Committee on Justice and Human Rights, and a member of various standing committees;

WHEREAS, he was dubbed as one of 'Manila's Seven Wise Men in the City Council for drafting, preparing, and causing the approval of the Rules and Procedures of the City Council;

WHEREAS, he received the "Leadership Award" and the "Gawad Karangalan Award" for his brilliant and exemplary performance as a Councilor of Manila;

WHEREAS, in 1991, he was chosen as one of the Most Outstanding Councilors of Manila' for his effective sponsorship of quality legislation and active participation during floor deliberations;

WHEREAS, he was considered by the Philippine Reporter Magazine as one of the "Rising Political Stars of Manila;


WHEREAS, he also served as Legal Counsel at the office of then Vice-Mayor Danilo "Danny" Bautista Lacuna Sr.;

WHEREAS, on the 16th of February 2025, Councilor Atty. Nemesio C. Garcia, Jr. passed away at the age of 82, leaving behind a legacy of his service and integrity to the people of Manila: NOW, THEREFORE, be it
