**RESOLUTION** GRANTING THE HONORABLE CITY MAYOR, MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, REPRESENTING THE CITY GOVERNMENT OF MANILA, AUTHORITY TO SIGN A DEED OF DONATION AND ACCEPTANCE WITH THE DEPARTMENT OF HEALTH-METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD), AS REGARDS THE DONATION OF ONE (1) UNIT OF AMBULANCE TYPE I, INCLUSIVE OF MEDICAL EQUIPMENT, WORTH APPROXIMATELY ONE MILLION NINE HUNDRED FORTY-EIGHT THOUSAND PESOS (PHP1,948,000.00) IN FAVOR OF THE CITY OF MANILA

WHEREAS, in a letter dated January 31, 2025, Dr. Arnold M. Pangan, MD, RSW, MPA, MMHoA, City Government Department Head III, City Health Officer, wrote a letter to the City Council requesting for the adoption of a resolution granting the Local Chief Executive to sign a Deed of Donation and Acceptance with the Department of Health-Metro Manila Center for Health Development (DOH-MMCHD), for the donation of one (1) Ambulance Type I, inclusive of medical equipment, worth approximately One Million Nine Hundred Forty-Eight Thousand Pesos (PhP1,948,000.00) to the City of Manila;


WHEREAS, the letter-request, together with the proposed Deed of Donation and Acceptance, was referred to the City Council for appropriate action;

WHEREAS, Section 22(c) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, empowers the Local Chief Executive to enter into contract on behalf of the local government unit upon prior authorization by the Sanggunian concerned: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant as it hereby grants the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, authority to sign a Deed of Donation and Acceptance with the Department of Health-Metro Manila Center for Health Development (DOH-MMCHD), as regards the donation of one (1) Ambulance Type I, inclusive of medical equipment, worth approximately One Million Nine Hundred Forty-Eight Thousand Pesos (PhP1,948,000.00) in favor of the City of Manila; and be it FURTHER

RESOLVED, that the duly executed Deed of Donation and Acceptance entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
