AN ORDINANCE DECLARING HERBOSA STREET FROM NICOLAS ZAMORA STREET TO FRANCO STREET AS TEMPORARY RELOCATION SITE LOCATED BESIDE THE RECENTLY GUTTED PRITIL PUBLIC MARKET

EXPLANATORY NOTE

Section 21. Closure and Opening of Roads, from Republic Act 7160 also known as the Local Government Code of 1991 specifically states that "(a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, That in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided".

The urgent need for the temporary relocation of displaced stallholders in the gutted Pritil Public Market is paramount and that Herbosa Street from Nicolas Zamora Street to Franco Street is the chosen relocation site.

To formalize and legalize the temporary relocation this, honorable august body needs to declare the aforementioned temporary relocation site temporarily withdrawn from public use until such time that the displaced stallholders of Pritil Public Market can be transferred to the soon to be constructed New Pritil Public Market.

Be it ordained by the City Council of Manila, in session assembled, *THAT*:


SECTION 1. That a portion of Herbosa Street from Nicolas Zamora Street to Franco Street is hereby declared as temporary relocation site for the transfer of stalls for Pritil Public Market Stallholders, pursuant to the prepared sectioning plans hereto attached which form as an integral part of this Ordinance and marked as Annex "A", Annex "B" and Annex "C".

SEC. 2. The relocation site identified herein shall exclude sidewalks and pedestrian lanes existing in the area.

SEC. 3. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 18, 2025.




