**RESOLUTION** CONCURRENCE THE SIGNED APPOINTMENT OF ATTY. EDUARDO "WARDEE" P. QUINTOS XIV AS CITY GOVERNMENT DEPARTMENT HEAD III (CITY ADMINISTRATOR) OF THE CITY OF MANILA, PURSUANT TO SECTION 454(D) OF REPUBLIC ACT NO. 7160 OTHERWISE KNOWN AS THE "LOCAL GOVERNMENT CODE OF 1991"

WHEREAS, Section 11 of Republic Act No. 409 or the Revised Charter of the City of Manila states that: "General duties and powers of the mayor..."

xxx xxx xxx

d) Subject to the provisions of the Civil Service Law, to appoint all officers and employees of the City Council of Manila..."

WHEREAS, in connection therewith, Section 454, Chapter II of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991" provides that "(d) unless otherwise provided herein, heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed.

WHEREAS, Section 455 of the same code provides that:

"(a) The city mayor, as chief executive of the city government, shall exercise such powers and perform such duties and functions as provided by this Code and other laws.

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of this Code, the city mayor shall:

xxx xxx xxx

(v) Appoint all officials and employees whose salaries and wages are wholly or mainly paid out of city funds and whose appointments are not otherwise provided for in this Code, as well as those he may be authorized by law to appoint";

NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to concur, as it hereby concurs the signed appointment of Atty. Eduardo "Wardee" P. Quintos XIV as City Government Department Head III (City Administrator) of the City of Manila, pursuant to Section 454(d) of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991"; and be it FURTHER

RESOLVED, that a copy of this Resolution be furnished the Office of the City Administrator.
