**RESOLUTION** RATIFYING THE CONTRACT ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT OF MANILA AND LEONEL WASTE MANAGEMENT CORPORATION FOR THE GARBAGE COLLECTION AND DISPOSAL SERVICES OF THE SIX (6) DISTRICTS OF MANILA FOR THE PERIOD COVERED FROM JULY 01, 2025 TO AUGUST 31, 2025

WHEREAS, the City Council of the City of Manila through Resolution No. 147, Series of 2025 declared a State of Public Health Emergency in the City of Manila and authorized the City Mayor to immediately engage with any qualified or available service provider, in accordance with applicable procurement laws, to address such vital public service and such other measures necessary and incidental to its implementation;

WHEREAS, pursuant to the directives of the City Mayor, as the Head of Procuring Entity, the Department of Public Services, as the End-User/Implementing Unit, conducted negotiations with the Leonel Waste Management Corporation for the Garbage Collection and Disposal Services for the six (6) districts of Manila for the period of July 01, 2025 to August 31, 2025 under Negotiated Procurement (Emergency Cases), in accordance with Section 35.2 of the Implementing Rules and Regulations of Republic Act No. 12009;

WHEREAS, Leonel Waste Management Corporation was found to be legally, technically and financially capable of providing the necessary services and thus awarded the contract in order to avoid an imminent public health crisis;

WHEREAS, for the endeavor above stated, the Chief Executive of the City has authorized the City Administrator to make the necessary transmittal to the City Council of the pertinent records and other basic papers relative to the above contract: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to ratify, as it hereby ratifies the contract entered into by and between the City Government of Manila and Leonel Waste Management Corporation for the garbage collection and disposal services of the six (6) districts of Manila for the period covered from July 01, 2025 to August 31, 2025; and be it FURTHER

RESOLVED, that the duly executed contract be made as an integral part of this Resolution.
