**RESOLUTION ENCOURAGING PARENTS AND GUARDIANS OF STUDENTS IN PUBLIC SCHOOLS IN THE CITY OF MANILA TO SUPPORT AND AVAIL OF THE FREE VACCINATION UNDER "BAKUNA ESKWELA" PROGRAM**

WHEREAS, vaccination is a proven and effective public health measure that protects children from serious diseases, ensures safe learning environments and contributes to the overall well-being of the community;

WHEREAS, the Department of Health (DOH) and the Department of Education (DepEd), in partnership with the City Government of Manila through the Manila Health Department (MHD), is implementing the "Bakuna Eskwela" program to promote health and prevent the spread of vaccine-preventable diseases among school children;

WHEREAS, the program offers free vaccinations against Measles, Rubella, Tetanus, Diphtheria, and Human Papillomavirus (HPV) for eligible students enrolled in public schools in the City of Manila;

WHEREAS, the free vaccination program will be conducted from July 28 to August 29, 2025 in participating public schools across the City of Manila;

WHEREAS, the scheduled vaccinations are as follows:

- Grade 1 and Grade 7: Measles, Rubella (MR), and Tetanus, Diphtheria (Td)
- Grade 2: MR Td Catch-up
- Grade 4 (Female Only): Human Papillomavirus (HPV)

WHEREAS, the City Council of Manila enjoin all relevant stakeholders to collaborate in safeguarding the health of Manila's schoolchildren through timely and accessible immunization efforts: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to encourage, as it hereby encourages parents and guardians of students in public schools in the City of Manila to support and avail of the free vaccination under "Bakuna Eskwela" Program; and be it FURTHER

RESOLVED, that copies of this Resolution be furnished to the Manila Health Department (MHD), the Department of Education - Manila Division, and all public schools in the City of Manila for their guidance and appropriate action.
