WHEREAS, the Sangguniang Panlungsod of the City of Manila acknowledge and commends acts of bravery and exemplary public service performed by Police Staff Sergeant (PSSg) Raymon C. Ocampo with Badge No. 257678 and Patrolman Ralp Aldrin G. Yamat with Badge No. 340045 who are assigned at Meisic Police Station (PS-11) Binondo, Manila;

WHEREAS, PSSg Raymon C. Ocampo and Patrolman Ralp Aldrin G. Yamat of the Manila Police District (MPD) risked their lives in the line of duty while carrying out their sworn responsibilities to protect and serve the citizens of Manila during a robbery which transpired on July 28, 2025 along Muelle dela Industria corner Juan Luna Street in Binondo, Manila and recovered from suspect a .38 caliber revolver without serial number and loaded four (4) live ammunition and one (1) fired cartridge case on its cylinder likewise one unit of Samsung Cell phone worth Twenty-Five Thousand Pesos (PhP25,000.00) and cash money amounting Three Thousand Pesos (PhP3,000.00) were also recovered;

WHEREAS, it is fitting and proper to recognize their heroism and self-sacrifice, and to urge the Philippine National Police (PNP) to consider them for meritorious promotions a just and appropriate rewards for their courage and service to the nation: NOW, THEREFORE be it

RESOLVED, by the City Council of Manila to urge the Philippine National Police to consider them for meritorious promotion in view of their courage and to risk their lives in the line of duty; and be it FURTHER

RESOLVED, by the City Council of Manila to commend, as it hereby commends the exceptional bravery of Police Staff Sergeant Raymon C. Ocampo (Badge No. 257678) and Patrolman Ralp Aldrin G. Yamat (Badge No. 340045); and be it FINALY

RESOLVED, that copies of this Resolution be furnished to the Department of the Interior and Local Government (DILG), the Philippine National Police (PNP), the National Capital Region Police Office (NCRPO) and the Manila Police District (MPD).
