
WHEREAS, Sub-section (a), Article 119 (Appointive Local Officials) of the Implementing Rules and Regulations of R.A. 7160 (Local Government Code of 1991), states that: *"unless otherwise provided in this Rule, heads of offices and departments in the LGU's shall be appointed by the local chief executive concerned with the concurrence of a majority of all the members of the Sanggunian, subject to civil service laws, rules and regulations"*;

WHEREAS, in connection therewith, Section 454, Chapter II of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991" provides that "(d) unless otherwise provided herein, heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed";

WHEREAS, after a careful study and evaluation of the appointee's qualifications and other pertinent documents, the City Council of Manila finds that he is highly qualified to occupy the position: NOW THEREFORE, be it:

RESOLVED, by the City Council of Manila to manifest, as it hereby manifests its concurrence to the appointment of Attorney Hans Roger S. Luna, as City Government Department Head III (Secretary to the City Council).
