RESOLUTION ADOPTING AND APPROVING RESOLUTION NO. 02, SERIES OF 2025, PASSED BY THE LOCAL HEALTH BOARD ON JULY 17, 2025, ENTITLED: "A RESOLUTION APPROVING THE UTILIZATION OF SEVEN HUNDRED FIFTY MILLION PESOS (PHP 750,000,000.00) FROM THE SPECIAL HEALTH FUND (SHF) FOR THE IMPLEMENTATION OF PRIORITY HEALTH PROGRAMS, SERVICES, AND OPERATIONAL NEEDS OF THE MANILA HEALTH DEPARTMENT (MHD) AND THE SEVEN (7) LOCAL GOVERNMENT UNIT (LGU) HOSPITALS FOR FISCAL YEAR 2025"

WHEREAS, the Local Health Board was convened, by virtue of Section 102(a) of Republic Act 7160 otherwise known as the Local Government Code of 1991, which provides that a Local Health Board shall be established in every province, city or municipality, and provided for its functions under paragraph (b) of Section 102 thereof;

WHEREAS, Section 16 of the same law mandates local government units to promote general welfare, health and safety of its constituents; enhance economic prosperity and social justice; and preserve the comfort and convenience of their inhabitants;

WHEREAS, the City of Manila aims to promote the health, safety and welfare of its citizens, pursuant to Republic Act No. 11223 otherwise known as the "Universal Health Care Act";

WHEREAS, in consonance with the mandates of Universal Health Care Act, Joint Memorandum Circular No. 2021-0001 was issued on January 13, 2021 by the Department of Health (DOH), the Department of Budget and Management (DBM), Department of Finance (DOF), the Department of the Interior and Local Government (DILG) and the Philippine Health Insurance Corporation (PhilHealth);

WHEREAS, Joint Memorandum Circular 2021-0001 especially calls for the creation of a distinct account known as the Special Health Fund (SHF) in relation to the integration of local health systems into Province-Wide/City-Wide Health Systems (P/CWHS), as mandated by the Universal Health Care Act: NOW THEREFORE, be it

RESOLVED, by the City Council of Manila to adopt and approve, as it hereby adopts and approves Resolution No. 02, Series of 2025, passed by the Local Health Board on July 17, 2025, entitled: "A RESOLUTION APPROVING THE UTILIZATION OF SEVEN HUNDRED FIFTY MILLION PESOS (PHP 750,000,000.00) FROM THE SPECIAL HEALTH FUND (SHF) FOR THE IMPLEMENTATION OF PRIORITY HEALTH PROGRAMS, SERVICES, AND OPERATIONAL NEEDS OF THE MANILA HEALTH DEPARTMENT (MHD) AND THE SEVEN (7) LOCAL GOVERNMENT UNIT (LGU) HOSPITALS FOR FISCAL YEAR 2025"; and be it FURTHER

RESOLVED, that Resolution No. 02, Series of 2025, passed by the Local Health Board be made part of this Resolution.
