SECTION 1. Exemption from payment of the Mayor's Permit Fee is hereby granted and authorized in favor of the participating merchants to sell some of the province of Laguna's products at Kartilya ng Katipunan on September 15, 16, and 17, 2025.


SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon approval.
