ORDINANCE NO. 9121

AN ORDINANCE APPROPRIATING THE SUM OF THREE HUNDRED MILLION PESOS (PHP300,000,000.00) FROM SAVINGS OF ANY AVAILABLE LOCAL FUNDING SOURCE TO IMMEDIATELY ATTEND TO AND ADDRESS THE URGENT MEDICAL, OTHER SOCIAL, EDUCATIONAL AND ECONOMIC NEEDS OF CONSTITUENTS/RESIDENTS OF THE CITY OF MANILA WHO ARE IN SERIOUS NEED OF ASSISTANCE AND FOR OTHER PURPOSES

EXPLANATORY NOTE

Sec. 16 of Republic Act No. 7160 or the Local Government Code of 1991 provides that every local government unit shall exercise its powers, express or implied, for efficient and effective governance, and those essential for the promotion of the general welfare. Towards this end, LGUs shall ensure and support, among others, promotion of health and safety, as well as preservation of the comfort and convenience of their inhabitants.

As directly observed and witnessed during the recently concluded National and Local Elections in the City of Manila, many of the constituents/residents of the city were deprived of the most urgent basic medical, other social, educational and economic needs most especially due to lack of medicines, medical supply and/or poor health facilities in various health centers or local hospitals and weak management of medical personnel that often result to poor health care service.

To effectively address the ever growing discontent and previous grievances, the new set of City Officials lost no time to mobilize essential personnel in order to gather much vital information on needy constituents-residents and thus, this Ordinance shall hereby be known and called, "Kaagapay ng Batang Maynila Ordinance".

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Title. – This Ordinance shall be known as the “Kaagapay ng Batang Maynila Ordinance”.


SEC. 2. Appropriations. – The amount of Three Hundred Million Pesos (PhP300,000,000.00) is hereby appropriated from savings of any available local funding source for the effective and efficient implementation of the “Kaagapay ng Batang Maynila Ordinance”.

SEC. 3. Separability Clause. – If any provision of this Ordinance is hereby declared invalid and unconstitutional, other provisions not affected thereby shall remain valid and in full force and effect.


SEC. 4. Effectivity Clause. – This Ordinance shall take effect upon its approval and after publication in a newspaper of general circulation.

This Ordinance was enacted by the City Council of Manila on July 29, 2025.
