
EXPLANATORY NOTE

The Ospital ng Maynila Medical Center was established to provide quality healthcare services to the people of the City of Manila.

The original idea and initiative for its establishment came from former Mayor Arsenio H. Lacson, whose vision for public healthcare set the groundwork for its creation.

This vision was carried forward and realized under the administration of former Mayor Antonio J. Villegas, who ensured the continuation and eventual establishment of the hospital as a vital institution in the city.

Both mayors Lacson and Villegas made significant contributions to the health and welfare of the Manileños, and it is fitting and proper to recognize their enduring legacies through the renaming of the hospital.

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Title. – This Ordinance shall be known as the "Renaming of the Ospital ng Maynila Medical Center Ordinance of 2025".

SEC. 2. Renaming. – The "Ospital ng Maynila Medical Center" is hereby renamed to "OSPITAL NG MAYNILA LACSON-VILLEGAS MEDICAL CENTER".

SEC. 3. Signage and Official Documents. – All official documents, letterheads, signages, and references to the hospital shall henceforth use the new name. The appropriate departments shall oversee the replacement of existing signs and materials within ninety (90) days from the effectivity of this Ordinance.


SEC. 4. Separability Clause. – If, for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof, which are not affected thereby, shall continue to be in full force and effect.

SEC. 5. Repealing Clause. – All ordinances, rules and regulations that are inconsistent with this Ordinance are hereby amended accordingly.


SEC. 6. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.


