## **ORDINANCE NO. 9124**

AN ORDINANCE APPROVING THE REALIGNMENT/TRANSFER OF ONE HUNDRED SEVENTY MILLION PESOS (PHP170,000,000.00) FROM SAVINGS UNDER THE DONATIONS ACCOUNT OF THE OFFICE OF THE MAYOR AUTHORIZED THROUGH ORDINANCE NO. 9075 OTHERWISE KNOWN AS "THE EXECUTIVE BUDGET FOR FY 2025" TO AUGMENT THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) OF THE DEPARTMENT OF PUBLIC SERVICES (DPS) AND FOR OTHER PURPOSES

## **EXPLANATORY NOTE**

The City Council of Manila through Resolution No. 147, Series of 2025, declared a State of Public Health Emergency to address the garbage crisis and its probable outbreak, if no intervention are made, of epidemic and dangerous diseases in all the six districts of Manila.

The City Government of Manila is made aware of the imminent closure of the Navotas Sanitary Landfill and thus, left with no other option of choice but to necessitate realignment/transfer of budget to augment and cover the costs related with the ancillary services of garbage hauling from its existing site to an MMDA-accredited sanitary landfill for the remainder of the calendar year.

And since there are funds certified as available for realignment in the amount of One Hundred Seventy Million Pesos (PhP170,000,000.00) from Donations Account of the Office of the Mayor to the Department of Public Services (DPS) and thus, there is a need to transfer the said amount in order to directly satisfy accruing obligation as a result of its landfill closure and thus, altogether avoid another possible health risk to the citizens of the City of Manila.

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. The realignment/transfer of the amount of One Hundred Seventy Million Pesos (PhP170,000,000.00) from Donations Account of the Office of the Mayor pursuant to Ordinance No. 9075 otherwise known as the "Executive Budget for FY 2025", to the Maintenance and Other Operating Expenses (MOOE) of the Department of Public Services (DPS) to augment its budgetary requirement for Sanitary Services is hereby approved, subject to existing accounting, budget and auditing, laws, rules and regulations.

**SEC. 2.** Copies of this Ordinance be furnished to the City Budget Office, City Treasurer's Office, Accounting Department and other concerned offices for their information and guidance.

SEC. 3. This Ordinance shall take effect immediately upon its approval.

This Ordinance was enacted by the City Council of Manila on August 12, 2025.
