**ORDINANCE NO. 9127**

**AN ORDINANCE** DECLARING OLD ANTIPOLLO STREET, FROM ABAD SANTOS  
AVENUE TO RIZAL AVENUE, AS ONE-WAY STREET

## **EXPLANATORY NOTE**

The Department of Transportation (DOT), together with the Philippine National Railways (PNR), is currently implementing the North South Commuter Railway Extension Project (NSCR-Ex Project), a 110-kilometer railway line that forms that part of larger NSCR system, and connects Metro Manila to the provinces of Pampanga, Bulacan, and Laguna.

The NSCR-Ex Project is being carried out in accordance with Republic Act No. 10752, otherwise known as the "Right-of-Way Act of 2016".

Land acquisition for the project begins along Old Antipolo Street in Barangay 217, Tondo, Manila, and the clearing and fencing of the said street is a crucial milestone, as it will enable the construction of 18 piers in the area.

The implementation of the NSCR-Ex Project is expected to cause significant traffic congestion along Old Antipolo Street and adjoining city and national roads, adversely affecting commuters and must therefore be addressed through traffic mitigation measures.

It is necessary to declare Old Antipolo Street as a one-way street, specifically from Abad Santos Avenue to Rizal Avenue, to facilitate smoother traffic flow during and after the project's implementation.

Section 16 of Republic Act No. 7160, otherwise known as the "Local Government Code of the Philippines", provides that every local government unit shall exercise the powers expressly granted, those necessarily implied and those essential to the promotion of the general welfare.

Be it ordained by the City Council of Manila, in session assembled, *THAT*:


**SECTION 1. Title.** – Old Antipolo Street, from Abad Santos Avenue up to Rizal Avenue, is hereby declared as one-way street.

**SEC. 2. Repealing Clause.** – All ordinances, rules and regulations inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.


**SEC. 3. Effectivity Clause.** – This Ordinance shall take effect immediately upon approval.

This Ordinance was enacted by the City Council of Manila on August 14, 2025.
