RESOLUTION GRANTING THE TEMPORARY CLOSURE OF I. DELOS REYES STREET CORNER P. NOVAL STREET, SAMPALOC, MANILA, FOR THE ESTABLISHMENT OF A FOOD PARK "FUSION ALLEY" IN THE HEART OF U-BELT AS PART OF ITS LIVELIHOOD PROGRAM FROM 5:00 IN THE AFTERNOON UNTIL 12 MIDNIGHT THE SAME DAY

WHEREAS, the street of I. Delos Reyes Street corner P. Noval Street, in Sampaloc, Manila, shall be temporarily closed as part of its livelihood program wherein Trade Fair and various flea market nightly activities such as selling of goods, merchandise, foodstuffs, commodities, to name a few, will be conducted at the above-mentioned street from 5:00 in the afternoon until 12:00 midnight the same day;

WHEREAS, Local Government Code of 1991 provides among others, under Section 21 (a) and (c), to wit:

"Closure of Roads - (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction.....xxx; (c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and waterworks projects, the duration of which shall be specified by the local chief executive concerned in a written order... xxx;"

WHEREAS, for humanitarian reasons, the temporary closure of said street aims to contribute to uplift and develop the quality of life of the members of the community, by launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Sanggunian of Zone 46, District IV unanimously voted for the passage of a resolution temporarily closing the above-mentioned street;

WHEREAS, in connection with the above-mentioned purpose, the street of I. Delos Reyes Street corner P. Noval Street, Zone 46, Sampaloc, Manila shall be temporarily closed to motor vehicles from 5:00 in the afternoon until 12:00 midnight the same day;

WHEREAS, the Barangay Officials of the barangays included from Zone 46, Sampaloc, Manila, with the aid of its Barangay Tanods, and the Hawker's Division of the City to facilitate such food park and shall facilitate the implementation of this Resolution and shall maintain the peace and order of the area for the entire duration of this temporary closure: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the temporary closure of I. Delos Reyes Street corner P. Noval Street, Sampaloc, Manila, for the establishment of a Food Park "Fusion Alley" in the heart of U-Belt as part of its livelihood program from 5:00 in the afternoon until 12 midnight the same day.
