RESOLUTION URGING THE CITY GOVERNMENT OF MANILA TO ACTIVELY PROMOTE THE EXPRESSION "KEEP RIGHT" AS A DEMONSTRATION OF BASIC COURTESY AND DISCIPLINE TO BE OBSERVED AT ALL TIMES IN MANILA AND TO EARNESTLY REQUEST FROM PUBLIC AND PRIVATE OFFICES, INSTITUTIONS AND ESTABLISHMENTS TO DISPLAY APPROPRIATE SIGNAGES THEREOF

WHEREAS, the phrase “*Keep Right*” is normally associated as a Road Sign that directs the drivers to stay on the right side of the road in order to veer away from any possible road obstructions;

WHEREAS, the synonymous idiom “*Staying on the Right Side*” can either refer to avoiding the wrath of someone or obeying the law;

WHEREAS, in various ways and situations in our daily lives, this important expression “*Keep Right*” becomes handy in avoiding accidents, maintaining orderliness and promoting harmony between and among fellow citizens;

WHEREAS, in the case of students, keeping right while going up the stairs or walking along the corridors or lining up in the canteen helps prevent chaos and conflicts inside the school premises;

WHEREAS, for pedestrians and motorists, keeping right will greatly minimize traffic accidents and road rage incidents since this all-important phrase reminds everyone to stay on your proper lane and to give way to passing vehicles;


WHEREAS, as for people patronizing or availing of services in institutions and establishments, clients and customers shall be directed to line up in an orderly fashion at the right-side lane of the receptionist or cashier: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to urge, as it hereby urges the City Government of Manila to actively promote the expression “*Keep Right*” as demonstration of basic courtesy and discipline to be observed at all times in Manila and to earnestly request from public and private offices, institutions and establishments to display appropriate signages thereof; and be it FURTHER

RESOLVED, that copies of this Resolution be furnished to the Office the Mayor, Office of the City Administrator, Schools Division Office of Manila, Manila Barangay Bureau (MBB), Manila Traffic and Parking Bureau (MTPB), Manila Police District (MPD) and Bureau of Permits; and be it FINNALLY


RESOLVED, to direct the Manila Public Information Office (MPIO) to disseminate the purpose of this Resolution in all social media and accounts maintained by the City Government.
