WHEREAS, Article II, Section 5 of the 1987 Philippine Constitution declares that "the maintenance of peace and order, the protection of life, liberty and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy", thereby affirming the State's duty to support public safety initiatives at all levels of government;

WHEREAS, Article II, Section 20 of the Constitution recognizes "the indispensable role of the private sector", and Article II, Section 23 encourages non-governmental and community-based organizations that promote the welfare of the nation, constitutional policies that validate civic-government partnerships to advance peace and order;

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", vests in local government units the authority to exercise powers necessary, appropriate, or incidental to promote the general welfare, including measures that support law enforcement and community safety within their jurisdictions;


WHEREAS, Section 458(a)(1) of the local government code empowers the Sangguniang Panlungsod, as the city's legislative body, to enact ordinances and approve resolutions for the general welfare of the city and its inhabitants, encompassing acts of recognition and commendation that foster civic cooperation and public safety;

WHEREAS, the Federation of Filipino-Chinese Chambers of Commerce and Industry, Inc. (FFCCCII), through its corporate social responsibility programs and in partnership with the City of Manila and the Manila Police District (MPD), generously donated thirty (30) Yamaha NMAX motorcycles to the MPD to augment patrol mobility and rapid response an initiative publicly acknowledged by city officials and FFCCCII leadership;


